Net Generation of Subsidiary Power Plants Increased by 5.8%,
among which Subsidiary Wind Farms Increased by 8.5%,
Photovoltaic Plants Increased by 177.9%**

Total net generation of subsidiary power plants in August 2024 increased by 10.0% year on year to 19,041,450 MWh, among which, subsidiary wind farms increased by 15.2% year on year to 2,493,441 MWh, subsidiary photovoltaic plants increased by 125.7% year on year to 770,548 MWh.

Total net generation of subsidiary power plants for the first eight months of 2024 increased by 5.8% year on year to 135,665,770 MWh, among which, subsidiary wind farms increased by 8.5% year on year to 28,504,275 MWh, subsidiary photovoltaic plants increased by 177.9% year on year to 4,629,675 MWh.
